Headed into a new year, we recommend that you review your accounts and the contact information on them. Having accurate information is vital to us, but also important for you. Without correct info, there could be lags in communication with you as our member which we don't want to see. Have you moved? Let's get that address and phone number updated. With this information, we can quickly communicate with you or send you a text so you are up-to-date with information on your account. Do you have a pay-on-death beneficiary? If you do, is that person's name, and contact information accurate? Sometimes these updates can be forgotten when a beneficiary goes through a name change.
